Dated, Chandigarh,

The Governor of Haryana is pleased to issue following orders u/s 33 of the Act in consonance with the "The Haryana Pond and Waste Water Management Authority Act, 2018" until rules are framed:-

(a) As per the para 8(i) of the Act, the EVC shall have the full powers to accord administrative approval to all projects' estimates upto Rs. 50 lakh.

(b) The EVC shall accord administrative approval to all projects' estimates beyond Rs. 50 lacs, subject to concurrence of the Authority.

(ii)

- The construction and development works may be carried out by the PR-PW wing of Development & Panchayats Department, and Irrigation and Water Resources Department (IWRD). In this regard, Engineer- in Chief, IWRD and Chief Engineer, PR-PW may be directed to execute such works, as directed by Authority from time to time. Engineer-in Chief, IWRD and Chief Engineer, PR-PW may also be directed that such construction and development works will be carried out by these Department under the control of the Pond Authority Haryana within the stipulated time fixed by the Authority.
- Further, the Authority shall have full control over the quality of work done by such Departments (iii) or its executing agency and will have full right to inspect the work and its related documents as and when required and make necessary inquiry, if need to be.
- (iv) The Authority shall also be empowered to recommend suitable disciplinary action against the erring officials, to the concerned Administrative Secretaries to the State Governments, if work/performance is not found to be satisfactory or the work is not executed within stipulated time fixed by the Authority.

Any direction issued by the Authority shall be binding on the Executing Department such as (v) Development & Panchayats Department and Irrigation Department and its agency executing any

work and on its employees responsible for the execution of any work.

The above powers on behalf of the Authority shall be exercised by the Executive Vice-(vi) Chairperson of the Pond Authority, Haryana through Additional Chief Secretary to Government, Haryana, Irrigation and Water Resources Department.
