7. Minimum Size of Logo shall be 4" X 4" (4 inches X 4 inches).
8. Last date for submission of entries is **31/03/2021**.
9. Logo shall not use any material (Photograph, icon, symbol etc) that is copyright protected. Anyone found infringing on others' copyright would be disqualified from the competition. The HPWWMA does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
10. The image of the logo should be at least of 600 dpi.
11. Logo designs should be submitted in jpg and pdf formats only.
12. The logo should be designed on a digital platform. The winner of the competition shall be required to submit the design in an editable and open file format.
13. Participants should not imprint or watermark logo design.
14. A small description should be provided to explain the concept.
15. The logo should be usable on the website/social media such as Twitter/ Facebook etc. and on printed material such as b/w press releases, stationeries and signage etc.
16. The Haryana Pond and Waste Water Management Authority (HPWWMA) reserves the right to cancel or amend all or any part of the competition and/or the terms/condition without any notice.
